## **Usage Terms and Conditions for the Motorcycle Track**

### 1. General Provisions:

- 1.1. The data protection disclaimer hereby confirms that the information and personal data you have submitted in connection with compliance with the rules will be collected, processed and stored in accordance with the requirements of European Union regulations regarding personal data protection. By submitting your data, you agree that the data is processed and stored for the entire period of data processing indicated here, as well as in the cases specified in the regulatory acts after the initial data processing for as long as it would be necessary. The collected data will not be transferred to third parties, except when such an obligation is imposed by regulatory acts. You have the right at any time to request the restoration of your data, information about the use of your personal data, as well as to request the deletion of your data;
- 1.2. These rules determine the order in which activities of the user (hereinafter the User) of the motorcycle track (hereinafter the Track) of SIA "Baltic Ring 333" take place during the riding session in general;
- 1.3. Track User is a person who participates in a riding session with a vehicle on a certain part/parts of the track.

#### 2. User responsibilities:

- 2.1. The user presents his/her identity document;
- 2.2. Users under the age of 16 may use the Track as a vehicle rider only with the continuous presence of parents/guardians or with the written permission of parents;
- 2.3. The User motorcyclist must enter the Track with a protective helmet and goggles intended for motorsports, shoes and gloves intended for motorsports. Back, neck, knee, elbow and rib guards are recommended;
- 2.4. The riding speed of the vehicle must be chosen according to the personal riding skills;
- 2.5. A safe riding distance must be observed;
- 2.6. If a part detaches from the vehicle due to certain damage during the use of the Track, it must be collected immediately, strictly observing safety measures on the Track;
- 2.7. If during the use of the Track, oil, fuel or coolant leaks from the vehicle due to certain damage, then, upon noticing this fact, you must immediately stop the ride, ride to the side of the track and fix the technical defect;
- 2.8. If any foreign bodies (parts, objects, substances, etc.) are found on the Track, which are located there as a result of other Users' riding sessions, then Track staff must be immediately informed of this fact;
- 2.9. If the User wants to change the configuration of the Track, this may only be done with the permission of the Track staff;
- 2.10. If the User has any questions or doubts about the riding session or the Track, the Track staff should be consulted, clarifying the question until it is fully understood;
- 2.11. If there are problems to continue riding, then the User must inform the Track staff about this fact;
- 2.12. In the rest of the Sports Complex 333 territory, which is outside the territory of the Track, the speed of any vehicle **may not exceed 30 km/h**;
- 2.13. Be careful with Track's belongings and equipment that are used and available during the session.

### 3. The User is strictly prohibited from:

- 3.1. Being at the Track under the influence of intoxicating substances;
- 3.2. Arbitrarily using the Track, without the permission given by the Track staff;
- 3.3. On the territory of the Track, the User is prohibited from spinning wheel on the spot or around his/her own axis in a circle, deliberately creating pits by spinning the vehicle on the spot, but this point does not prohibit starting the start procedure from the spot;
- 3.4. Arbitrarily changing the designated riding direction, configuration and stopping at the Track without a valid reason;
- 3.5. Stopping on the Track without a valid reason, however, if such a need arises, then the User must raise his/her hand to warn other motorcyclists and ride or push his/her vehicle off the Track, strictly following safety measures on the Track.

### 4. User responsibility:

- 4.1. Full responsibility for compliance with obligations and prohibitions, their execution and the resulting consequences;
- 4.2. Civil liability in accordance with the legal norms in force in the Republic of Latvia;
- 4.3. The rider of the vehicle is solely responsible for any damage to his/her or a third party's equipment while using the track;
- 4.4. Full responsibility that the vehicle with which the User participates in the ride along the Track is in technical order.

# 5. User rights:

- 5.1. To take the purchased trip/ride on the Track in compliance with these rules;
- 5.2. To ask any questions about the Track or a trip/ride on the Track and receive answers from the Track staff to questions of interest.

### 6. Various questions:

- 6.1. Company SIA "Baltic Ring 333" does not take responsibility for the Renter's personal material values;
- 6.2. In case of non-compliance with the above-mentioned rules, the User is given a verbal warning, if the User does not follow the given warning, the User is immediately denied participation in the driving session, without the right to renew it and the payment for the lesson is not returned;
- 6.3. Claims and demands arising during the use of the Track must be submitted in writing in a free form immediately at once after the end of the trip/ride;
- 6.4. If the User has any type of disputes or disagreements with any 333 third party, then mutual disputes must be resolved through negotiation, if this fails, the User and a third party settle disputes and disagreements in judicial institutions in accordance with the procedure specified in the regulatory legal acts of the Republic of Latvia;
- 6.5. If the User has any kind of disputes or disagreements with the staff of SIA "Baltic Ring 333", then mutual disputes must be resolved through negotiations, if this fails, in order to resolve the situation, the director of the company is invited to resolve the situation, if the situation is not resolved through discussions with the director then the parties resolve the disputes and disagreements that have arisen in the judicial institutions in accordance with the procedure specified in the regulatory legal acts of the Republic of Latvia;
- 6.6. The user has familiarized himself with the "Usage Terms and Conditions for the Motorcycle Track", fully understands them and undertakes to comply with them, which he confirms with his signature.

After receiving the service, this document will be safely disposed of.

Claims for the service can be raised 10 minutes after receiving the service.
